
Dear Chamber Member,

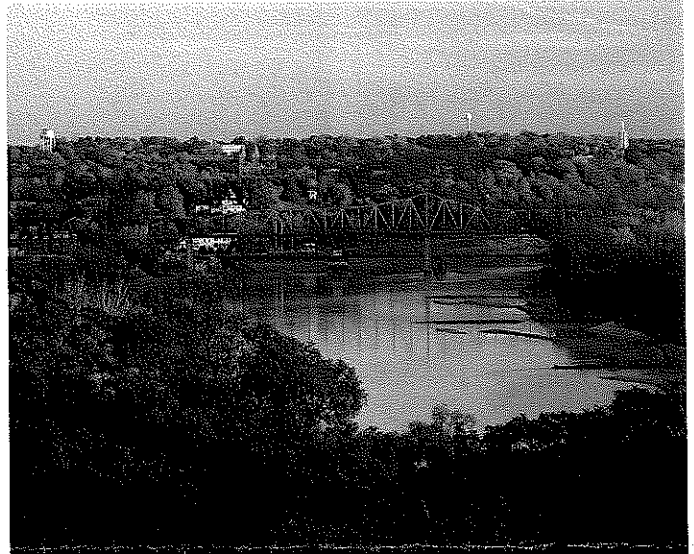
