LETTER TO PARENTS WHO FAIL TO PAY STUDENT FEES

Dear Parents,

Under the laws of Kansas, the school district may charge fees for the rental of textbooks (K.S.A. 72-4141) and assess fees and supplemental charges for activities, facilities, materials or equipment if participation in activities or the use of facilities, materials or equipment is optional to pupils (K.S.A. 72-5390).

If you are unable to pay these fees, the law allows for some of these fees to be waived (K.S.A. 72-4107a and 72-5391). In order to receive a waiver, however, you must make a written application for waiver to the Board of Education of Unified School District No. 377, and the Board must find the application meritorious. **The USD 377 Board determined that the Food Stamp Program Requirements and Social Rehabilitation Eligibility Listings shall determine the “classification” of students exempt from the book rental fee.** Anyone who falls within this classification may make written application to the Board of Education and to the attention of the Clerk of the Board.
